



## 2018 US1M National Championship Regatta

Hosted by Housatonic Model Yacht Club AMYA Sanctioned Club No. 117

September 22-23, 2018

*Updated -> 6-28-18*

**Rules:** The regatta will be governed by the rules as defined in World Sailing (formerly ISAF), The Racing Rules of Sailing (2017-2020) (RRS), as modified by Appendix E – Radio Sailing Rules, The Equipment Rules of Sailing (ERS), the US1M class rules, including the June 22, 2018 rule interpretation of Rule 5.1 regarding transmissions from the boat and other attached document, and the local Sailing Instruction provide at the regatta.

**Eligibility:** The regatta is open to all boats recorded with the A.M.Y.A. The skipper must be a member of either the A.M.Y.A. or other national governing body. Measurement and class authenticity will be conducted at check-in time.

**No On-Board Video Telemetry Allowed:** No on-board video telemetry is allowed anytime during racing.

The regatta is limited to 42 boats on a first come first serve basis.

**Location:** Bethany Veterans Memorial Park, 265 Beacon Road (Rt. 42), Bethany, CT 06524. There is no parking or entrance fee. There is sandy beach as well as a dock for launching boats and a rescue boat is available.

**Sailing Instructions:** Local sailing instructions will be provided at the regatta when skippers check in.

No races start after 3:00pm followed by awards

**Entry:** Eligible boats may be entered by completing the attached Entry Form and submitting it prior to September 15, 2018 with an entry fee of \$60.00 and \$70 after September 15. Guest may purchase a food ticket for \$10. Fee includes drinks, snacks and lunch both days.

**Scoring:** The scoring method will be governed by the Low Point Scoring method of the RRS Appendix A. There will be one throw out for every 8 races which will use the highest scores from the complete set of scores for each skipper in the regatta. If there are more than approximately 16 entries, either an Odd/even system, the CESSpool System or the Heat Management System (i.e. Promotion/Relegation) may be used at the discretion of the race committee and will be announced at the skipper's meeting.

**Prizes:** Prizes will awarded to 5<sup>th</sup> place plus AMYA Gold Chevrons.
