



## 2020 EC12 Fall Classic Regatta

Hosted by Housatonic Model Yacht Club AMYA Sanctioned Club No. 117

October 3<sup>rd</sup> & 4<sup>th</sup>, 2020

**Due to Covid-19, the Fall Classic is CANCELLED this year as a two-day regatta. We will hold a one-day race day on Saturday October 3<sup>rd</sup> at the Bethany venue where we will have a full day of racing (i.e. 10:00-3:30) with no trophies and everyone brings their own lunch. Masks and social distancing are required. There is no cost and no registration is required. All are welcome.**

**Rules:** The regatta will be governed by the rules as defined in World Sailing (formerly ISAF), The Racing Rules of Sailing (2017-2020) (RRS), as modified by Appendix E – Radio Sailing Rules, the EC12 Class Rules and the local Sailing Instruction provide at the regatta.

**Eligibility:** The regatta is open to all boats recorded with the A.M.Y.A. The skipper must be a member of either the A.M.Y.A. or other national governing body. Measurement and class authenticity may be conducted at check-in time.

**No Telemetry Allowed:** For the purpose of this regatta, the host club deems telemetry is “help from an outside source” in accordance to rule E4.2 and therefore, no telemetry except battery voltage sensing telemetry is allowed anytime during racing.

**Location:** Bethany Veterans Memorial Park, 265 Beacon Rd. (rt 42) , Bethany, CT 06524. There is no parking or entrance fee. A launch dock is available.

**Sailing Instructions:** Local sailing instructions will be provided at the skipper’s meeting

**Entry:** Eligible boats may be entered by completing the attached Entry Form and submitting it prior to October 1st, 2020 with an entry fee of \$35.00. Guest may purchase a food ticket for \$5. Fee includes drinks, snacks and lunch both days.

**Scoring:** The scoring method will be governed by the Low Point Scoring method of RRS Appendix A. There will be one throw out for every 8 races and will use the highest scores from the complete set of scores for each skipper in the regatta. If there are more than approximately 16 entries, either an Odd/even system, CESSpool, or the Heat Management System (i.e. Promotion/Relegation) may be used at the discretion of the race committee and will be announced at the skipper's meeting.

**Prizes:** Prizes will be awarded third place or more
