

#### 2021 Soling Regatta

### Hosted by Housatonic Model Yacht Club AMYA Sanctioned Club No. 117

#### June 19, 2021

<u>Rules:</u> The regatta will be governed by the rules as defined in World Sailing (formerly ISAF), The Racing Rules of Sailing (2021-2024) (RRS), as modified by Appendix E – Radio Sailing Rules, and the local Sailing Instruction provide at the regatta.

<u>Eligibility:</u> The regatta is open to all boats recorded with the A.M.Y.A. The skipper must be a member of either the A.M.Y.A. or other national governing body. Measurement and class authenticity may be conducted at check-in time.

<u>Team Eligibility:</u> There must be at least three members from a Region 1 club that race in the regatta. If more than three members race, the best three total scores are added together for the team score.

No On-Board Video Telemetry Allowed: No on-board video telemetry is allowed anytime during racing.

<u>Location:</u> Hop Brook Lake, 4 Straits Turnpike (Rt. 63), Middlebury, CT 06762. There is no parking or entrance fee. No dock is available, so boots or water shoes are required to wade into the water to launch boats.

Sailing Instructions: Local sailing instructions will be provided at the skipper's meeting

#### **Schedule:**

Saturday: 8:00am Registration

9:30am - Skippers Meeting

10:00am - First Race

~12:00pm - 12:45pm - Lunch

4:00pm - no race starting after 4:00pm followed by awards.

**Entry:** Eligible boats may be entered by completing the attached Entry Form and submitting it prior to June 17, 2021 with an entry fee of \$35.00. Guest may purchase a food ticket for \$5. Fee includes drinks, snacks and lunch both days.

<u>Scoring:</u> The scoring method will be governed by the Low Point Scoring method of RRS Appendix A. There will be one throw out for every 8 races and will use the highest scores from the complete set of scores for each skipper in the regatta. If there are more than approximately 16 entries, either an

Odd/even system, CESSpool, or the Heat Management System (i.e. Promotion/Relegation) may be used at the discretion of the race committee and will be announced at the skipper's meeting.

**Prizes:** Prizes will be awarded third place or more
